It is commonly used for alerts, reminders, marketing but also for information and communication between both staff and customers. You can group your contacts and message them in a single SMS. It is simple, fast and reliable.

- SMS will be sent through the Internet and received through the Internet.
  - 2. Online-Sender Offline-Receiver mode:
- SMS will be sent through the Internet and received through bulk SMS.
  - 3. Offline-Sender Online-Receiver mode:
- SMS will be sent through single paid SMS and received through the Internet.
  - 4. Offline-Sender Offline-Receiver mode:
- SMS will be sent through single paid SMS and received through bulk SMS.

OfflineSMS ("us", "we", or "our") operates the website and the OfflineSMS mobile

application (the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of

Types of Data Collected

Personal Data

# Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access the Service by or through a mobile device ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

## Tracking & Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.
